- 6.4 **551.074** For the purpose of considering the appointment, employment, resignation, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee

 - 2. Consider renewals, non-renewals, and terminations of contracts for professional and nonprofessional personnel
