- E. **551.074** For the purpose of considering the appointment, employment, resignation, evaluation,

reassignment, duties, discipline or dismissal of a public officer or employee

2. Consider renewals, non-renewals and terminations of contracts for professional and non-professional personnel

I. **551.083** For the purpose of considering the students, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representative of employee groups

J. **551.084** Excluding witness for a hearing
