- 5.4 **551.074** For the purpose of considering the appointment, employment, resignation, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee
 - 1. Consider hiring professional, and non-professional personnel
 - 2. Consider renewals, non-renewals, and terminations of contracts for professional and non-professional personnel
- 5.5 **551.076** For the purpose of considering the deployment, specific occasions for, or implementation of, security personnel or devices
- 5.6 **551.082** For the purpose of considering discipline of a public school child, or complaint or charge against personnel

- 5.8 **551.083** For the purpose of considering the students, guidelines, terms, or conditions the board will follow or will instruct its representatives to follow in consultation with a

representative of employee groups
